MANAGEMENT INSTRUCTION MANUALS AS-882-2011-6 AND ASM 273.172 VIA ARTICLE 19 OF THE

NATIONAL AGREEMENT WHEN THEY TOOK PICTURES OF EMPLOYEES WITHOUT THEIR CONSENT?

DID MANAGEMENT IN THE NASHVILLE INSTALLATION AT THE GREEN HILLS STATION VIOLATE ARTICLE 15.3.A OF THE NATIONAL AGREEMENT AND POSTAL SERVICE POLICY LETTER M-01517 WHEN THEY FAILED TO COMPLY WITH PREVIOUS DRT RESOLUTIONS?

As a result of a Formal Step A meeting of the Dispute Resolution Process we the parties agree to the following resolution of this grievance:

THE FORMAL A PARTIES AGREE THE CASE FILE CONTAINS A PREVIOUS PRECEDENT SETTING STEP B DECISION (C16N-4C-C 18439534) THAT STATES THE FOLLOWING:

The Dispute Resolution Team (DRT) has RESOLVED this grievance. The DRT determines Management will cease and desist photographing Letter Carriers in the performance of their duties and/or photographing mail pieces without the required approval notated in Management Instruction AS-882-2011-6.

Article 15.2 (Step B) of the National Agreement on JCAM page 15-8 states the following:

A Step B decision establishes precedent only in the installation from which the grievance arose. For this purpose, precedent means that the decision is relied upon in dealing with subsequent similar cases to avoid the repetition of disputes on similar issues that have been previously decided in that installation.
